

OVERVIEW OF INCOMING SIGNALS

The following information is based on incoming communication with the National Human Trafficking Hotline from January 1, 2020 – December 31, 2020 about human trafficking cases and issues related to human trafficking in Arkansas. Communication can take the form of **phone calls, SMS, Webchat¹, online tip reports², or emails**. Communication regarding topics unrelated to human trafficking are not included in this report. In 2020, the National Human Trafficking Hotline received a total of **295** substantive³ phone calls, SMS, Webchats, emails, or online tip reports from Arkansas.

² Online tip reports are a standardized form which can be completed on the website, allowing signalers to provide details without directly interacting with hotline staff.

³ Substantive signals excludes hang-ups, wrong numbers, missed signals and signals in which the National Hotline could not determine the signaler's reason for contacting the Hotline

SUBSTANTIVE SIGNAL DATA

The following statistics are based solely on substantive signals about human trafficking and issues related to human trafficking made to the National Human Trafficking Hotline between January 1, 2020 and December 31, 2020 from signalers in Arkansas at the time of their signal. Substantive signals exclude hang-ups, missed calls, wrong numbers, and signals in which the signaler's reason for contacting is unknown.

Number of Substantive Signals Received from Arkansas: **295**

This constitutes the 32nd highest signal volume of all 50 states and Washington, D.C. in 2020.

DATA ABOUT HUMAN TRAFFICKING SITUATIONS

Each request submitted to the hotline is evaluated for evidence of potential human trafficking. **In Arkansas, a total of 99 unique situations (incidents) of potential human trafficking were reported to the hotline.**

Requests for T&TA (Training and Technical Assistance) are situations in which service providers or law enforcement working with a victim of trafficking contact the National Hotline for technical assistance.

These cases are often submitted to the National Hotline through anonymous online tip reports.
