

NATIONAL HUMAN TRAFFICKING RESOURCE CENTER (NHTRC) DATA BREAKDOWN Human Trafficking Crisis Case Report 1/1/2011-12/31/2014

SUBSTANTIVE CALL DATA

During the four-year period between January 1, 2011 and December 31, 2014, a total of 4,613 substantive calls were made to the NHTRC regarding human trafficking crises. The following information is based on these calls.

HUMAN TRAFFICKING CASE DATA

Each request submitted to the NHTRC hotline is evaluated for evidence of potential human trafficking. During the four-year period between January 1, 2011 and December 31, 2014 a total of 963 unique cases (incidents) of human trafficking crises were reported to the NHTRC through hotline calls, online tip reports, or emails. The following information is based on these cases.

*These cases typically involve reports of sex trafficking in which an individual is advertised for commercial sex online but the venue of the sex act is unknown or not specified.

**To protect the identity of the people we serve, the NHTRC does not disclose exact statistics related to trafficking locations, venues, industries, victim information or caller information referenced fewer than three times.

***This typically occurs when a law enforcement agent or service provider contacts the NHTRC for resources and referrals but does not disclose details about the trafficking situation due to confidentiality. This category also includes cases in which the person reporting the information references human trafficking but does not provide further detail regarding the presence of labor or commercial sex. These cases are often submitted to the NHTRC through anonymous online tip reports.


