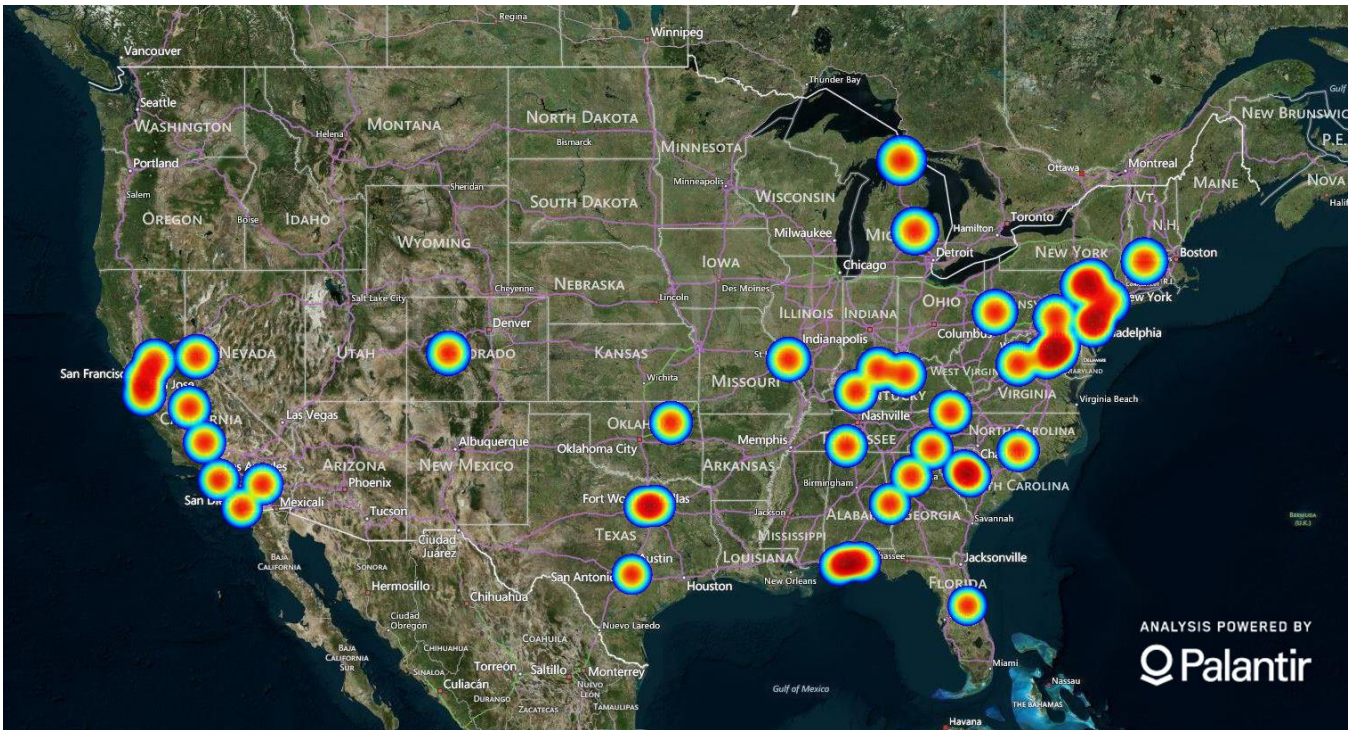


NATIONAL HUMAN TRAFFICKING RESOURCE CENTER (NHTRC) DATA BREAKDOWN

**Labor Trafficking in the Restaurant Industry
1/1/2014-12/31/2014**

Between 1/1/2014 and 12/31/2014, the NHTRC hotline received reports of 5,042 potential human trafficking cases believed to be occurring in the United States, of which 818 involve labor trafficking. 57 cases (7% of labor trafficking cases) involved labor trafficking in the restaurant and food services industry. The following report is based on these cases.
